

## **Europe Netball C Award Online Written Sample Paper No 1**

### Prepared July 2024, based on World Netball Rules of Netball 2024 edition

Time allowed: 30 minutes

The paper comprises 2 parts:

- Part One 25 questions: Pass Mark required for this section 21/25
- Part Two 5 questions: Pass Mark required for this section 3/5

## PART ONE - 25 questions: Pass Mark required for this section 21/25

## Instructions: For each question, Answer True or False

#	Question	True or False
1.	The match officials are two umpires, a reserve umpire, two scorers and two timekeepers.	
2.	The side lines of the court are each 50 ft long.	
3.	A line on the court which bounds adjacent court areas is common to both areas.	
4.	If a penalty pass is awarded to a team in its attacking goal circle before the timekeeper signals the end of play, the umpire must end play immediately.	
5.	If a team has more than 7 players on court at any time, the additional player/s are immediately sent from the court and possession is awarded to the opposing team where the ball was when play stopped.	
6.	Team officials may move onto the court surround to coach and/or provide hydration at a stoppage for injury/illness of a player or blood.	
7.	If a team delays taking the court after a stoppage when requested by the umpires, the umpire penalises the team for delaying play as soon as play resumes.	
8.	A late player may only enter the court after a goal has been scored.	
9.	In a match player monitoring devices may be worn provided they are secured within the playing uniform.	
10.	If a player takes a sanction or action from the incorrect position the umpire will award a penalty pass to the opposing team.	
11.	Advantage will be applied where the non-infringing team has a clear and real opportunity to play the ball.	
12.	The ball from a centre pass may not go untouched over the side line bounding the centre third.	



13.	A GS may not have contact with the ground outside the goal circle either while catching or holding the ball, before they take a shot for goal.	
14.	Without having possession of the ball, a player may bounce the ball and then bat the ball to another player.	
15.	While pivoting on the landing foot, a player may step with the second foot in any direction one or more times.	
16.	Offside only applies if that player is in possession of the ball.	
17.	A player may enter an offside area to retrieve a ball to set a sanction or action.	
18.	Possession will be awarded to the opposing team if a player stands out of court and attempts to defend an opposing player on the court.	
19.	An opposing player may attempt to defend a player who has possession of the ball, provided they are 0.9 m (3 ft) from the hands of the player with the ball.	
20.	It is not interference if a player accidentally pushes into or trips an opponent.	
21.	When two or more players jump into the air to touch or catch the ball, the player who gains possession must be permitted to land and any opponent/s must yield the landing place.	
22.	An umpire may choose whether or not to discipline a player who infringes any part of the foul play rule.	
23.	For dangerous play the game management action is a penalty pass and a warning.	
24.	At a centre pass, if one umpire blows the whistle for a sanction and the other umpire indicates an advantage has applied, the sanction will stand.	
25.	The umpire will award possession to the team who last had possession if two opposing players enter an offside area simultaneously and they both make contact with the ball.

## PART TWO - 5 questions: Pass Mark required for this section 3/5

Instructions: This Section contains 5 multiple choice questions: Put a tick in the box provided to indicate the correct answer. Only put a tick in one of the boxes for each question.

1. Red GD deflects the shot at goal on its downward flight towards the ring. The shot is unsuccessful as a result. What sanction should the umpire apply?

a. Free pass to the Blue team where the ball was deflected.	
b. No infringement and let play continue.	
c. Penalty pass to the Blue team where the infringer was standing	
(unless this places the non-infringing team at a disadvantage).	

2. The umpire notices a player is actively bleeding and neither team has called for time. What should the umpire do?

a. Ignore the blood and let play continue.	
b. Advise the player to call for time.	
c. Hold time and the player concerned must leave the court for	
treatment.	

3. Red GS leaves the court at the goal line to gain a better position. Blue GK follows the GS in an attempt to defend. Where would the sanction be positioned?

a. On the court in line with where the Blue GK was standing.	
b. On the court in line with where the Red GS re-entered the court.	
c. Inside and at the top of the circle.	

4. Red GS holds their hands over and towards Blue GK's eyes as Blue GK takes a Throw In from the goal line. What action will the umpire take?

a. Award a Penalty pass to the Blue team.	
b. Award a Penalty pass to the Blue team, which is advanced.	
c. Award a Free pass to the Blue team.	

5. What is the sanction for Delaying Play?

a. Penalty Pass and the Penalty is advanced.	
b. Warning and the Penalty is advanced.	
c. Penalty Pass, Warning and the Penalty is advanced.
