

Europe Netball C Award Online Written Sample Paper No 2

Prepared July 2024, based on World Netball Rules of Netball 2024 edition

Time allowed: 30 minutes

The paper comprises 2 parts:

- Part One 25 questions: Pass Mark required for this section 21/25
- Part Two 5 questions: Pass Mark required for this section 3/5

PART ONE - 25 questions: Pass Mark required for this section 21/25

Instructions: For each question, Answer True or False

#	Question	True or False
1.	Match officials are the umpires, reserve umpire, scorers and timekeepers.	
2.	The transverse lines are parallel to the goal lines and divide the court into three equal areas.	
3.	If two opposing players enter an offside area simultaneously and one player makes contact with the ball, a penalty pass is awarded.	
4.	The goal post is placed so that the back of the pole is on the inside edge of the goal line.	
5.	If a team is awarded a penalty pass in the centre third before the timekeeper signals the end of play, the penalty pass must be taken before play is ended.	
6.	Bench players may leave the team bench during play for a valid reason (such as to warm up).	
7.	If the position has been left vacant the late player may, after advising the umpire, take the court at the next break in play.	
8.	The umpires will ensure that the court meets the requirement of the rules and that this is maintained throughout the match to provide a safe environment for play.	
9.	A player taking a free pass may shoot for goal if they are wholly within the goal circle.	
10.	If a player is suspended or ordered off, a penalty pass is awarded to the non-infringing team and no player from the infringing team is required to stand out of play for the penalty pass.	
11.	A player taking the throw in does not have to wait for all players to be on the court before releasing the ball.	
12.	During a match the umpires may award possession of the ball to a team. If this is in the goal circle, a Goal Shooter or Goal Attack may either pass or shoot for goal.	

13.	If an umpire is applying advantage on a shot for goal and a goal is scored, then the umpire will signal the goal and will only state the infringement and the playing position of the infringer.	
14.	The first centre pass in each period of play is started by the umpire controlling the goal end of the team taking the centre pass.	
15.	At a centre pass the C cannot have her foot on the line bounding the centre circle.	
16.	If the whistle to end a period of play or hold time is blown after the ball has left the hands of the Goal Shooter or Goal Attack and the shot is successful, the goal will be disallowed.	
17.	When play is stopped for injury/illness or a player with blood only that player may be substituted.	
18.	If the number of requests for tactical changes becomes frivolous the umpires may refuse the request and penalise the infringing team for delaying play.	
19.	If a position has been left vacant due to illness/injury the player concerned or a substitute may return to the court at the next break in play.	
20.	After having possession and releasing the ball a player may not touch the ball if it rebounds from the goalpost.	
21.	A player who lands on both feet simultaneously may jump from both feet onto one foot, then reground the second foot before passing the ball.	
22.	A player who is standing outside the court defends a player who is on the court in possession of the ball. The umpire would award a penalty pass on the court where the player in possession of the ball is standing.	
23.	Contact that endangers player safety will normally be considered as dangerous play requiring the additional delivery of a Game Management action.	
24.	If an individual player has multiple advanced and/or escalated sanctions, the umpire must suspend the player.	
25.	The game management action for dangerous play is a penalty pass where the infringement occurred and the player is suspended or in a serious case ordered off.

PART TWO - 5 questions: Pass Mark required for this section 3/5

Instructions: This Section contains 5 multiple choice questions: Put a tick in the box provided to indicate the correct answer. Only put a tick in one of the boxes for each question.

1. Blue GA waves their arms erratically as Red GD attempts to pass the ball. What action will the umpire take?

a. Award a Free pass to the Red team.	
b. Award a Penalty pass to the Red team.	
c. Award a penalty pass to the Red team, which is advanced.	

2. A penalty pass is awarded to the Red team for contact by the Blue GD who does not release the ball quickly for the penalty to be taken. What is the umpires' decision?

a. Advance the penalty pass to be taken by the Red team.	
b. Wait for the Blue GD to release the ball so that the penalty pass can be taken.	
c. Advance the penalty pass to be taken by the Red team and the Blue GD is warned for delaying play.	

3. The ball is hit out of court by the Red WA and it touches the Blue WD who has moved into the court surround for the purpose of repositioning back onto the court. What action does the umpire take?

a. Award a throw in to the Red team to be taken in line with where the ball went out of court.	
b. Award a throw in to the Blue team to be taken in line with where the ball went out of court.	
c. Award possession to the Red team on court where the Red WA was positioned when they hit the ball out of court.	

4. Blue WD jumps to catch the ball and lands on their left foot first and then grounds their right foot. They then pivot on the ball of their left foot before putting their left heel down on the ground.

a. Free pass to Red team.	
b. No infringement, let play continue.	
c. Penalty pass to Red team.	

5. A Red GA attempts to pass the ball to their GS. The ball hits the net and the Red GA then catches the ball. What action should the umpire take

a. No infringement and play continues.	
b. Free pass to the Blue team where the Red GA passed the ball.	
c. Free pass to the Blue team where the Red GA caught the ball.
